Bathroom Facilities:

There is a bathroom facility located at the fairground's office by the horse barns and the campgrounds, which is equipped with showers. The bathroom facility is open May through October. It is the responsibility of the renter to arrange for additional portable restrooms in the event they are needed.

Cleanup:

Trash is to be picked up and placed in the barrels, if paying the trash fee. If not paying the trash fee, all trash must be placed in the dumpster.

Manure is to be removed from the barn(s) and placed in the designated bunkers, unless paying for the fairgrounds to clean stalls.

Damage/clean-up is discretionary, but renter is responsible for the cost of any damages to buildings or equipment.

Other Rental Information:

* All renters must supply (*prior to use*) a “Certificate of Liability Insurance” covering the scheduled activity/event.

*Only legally responsible adults over the age of 21 may schedule an event and rent the facilities.

The MCFA Horse Committee meets the second Wednesday of each month and the Fair Board meets the third Tuesday of each month. The Horse Committee and Fair Board will review and make a determination on each application on a first come/first serve basis. If you would like to be present at the meetings to answer any questions regarding your rental requests, please indicate this on your application.

Make check payable to MCFA Fairboard for the arena fee and another check to MCFA Horse Committee for all additional fees.
